Democracy in danger

AEH members should ask their governments and their representatives at the Parliamentary Assembly to sign up the written declaration of many of its members for supporting the DE-MOCRATIC REPRESENTATION OF THE CIVIL SOCIETY at the Council of Europe.

As reported in the previous Newsletters, AEH is active in this representation and contributes to the work of several committees in different domains among which the Council of Europe Action Plan for people with disabilities.

MENACE TO DEMOCRACY WITHIN THE COUNCIL OF EUROPE

Recommandation

adopted

by the Conference of International NGOs of the Council of Europe on October 6, 2010.

The Conference of INGOs shares the opinion of the Parliamentary Assembly "which is convinced that the success of the reforms proposed by the Secretary General must be based on genuine, substantial and ongoing dialogue not only between the two Statutory Organs but equally with the other bodies of the Organization." (Parliamentary Assembly, Opinion 276(2010)§5).

☑ The Conference of INGOs deplores that the Secretary General did not present to it his reform proposals, as he did to the Committee of Ministers, the Parliamentary Assembly and the Congress of Local and Regional Authorities, in the framework of the "Quadrilogue" but also in implementing Committee of Ministers/Res(2003)8, which foresees consulting the Conference of INGOs (at the time called Liaison Committee) on matters of mutual interest.

☑ The Conference of INGOs recognizes that the Secretary General's reform proposals come in a period of economic and financial instability which requires governments to consider reducing budgets.

In this difficult situation the Conference of INGOs could envisage a reduction in its own budget of the same order as those accepted by the Parliamentary Assembly and the Congress of Local and Regional Authorities. This despite its deep conviction that its indispensable role within the Council of Europe would justify a considerable increase in its means, given their very modest level.

☑ The Conference of INGOs recalls that for 2010 its allocated global budget is only 0.52% of the total budget of the Council of Europe. The reform budget proposed for 2011 foresees a substantial reduction up to 80 % according to statements, solely for the Conference of INGOs: this would not save the Council of Europe, but on the other hand could sacrifice one oh the members of the Quadrilogue : The Conference of INGOs.

In consequence the Conference of INGOs requests:

1. The Committee of Ministers:

- to reconfirm the statutory recognition of the Conference of INGOs
- to take note of its wish to be fully involved in the Council of Europe reform process and to contribute to it thanks to its expertise and its network covering the Europe of citizens.
- to make equitable reductions in the 2011 budget of the institutions of the Council of Europe
- to strengthen cooperation and dialogue among the pillars of the "Quadrilogue" so that the Council of Europe may continue, by its diversity and pluralism, to promote the interests of all European citizens better than any other organization.

2. The Parliamentary Assembly and the Congress:

- To support the proposals and wishes herein expressed to the Committee of Ministers and the Secretary General in order to preserve the unique role of the "Quadrilogue" which represents full European diversity and richness within the one Organization, the Council of Europe.

The 2011 budget will be adopted by the Committee of Ministers in the week of November 22, 2010.

Extract of the **address by the President of the Parliamentary Assembly, Mevlüt Çavuşoğlu**, at the INGO Conference plenary of 6 October:

« I wish to underline that you can count on the Assembly's support to ensure that our Organisation fully exploit the potential of the Conference of the INGOs, with a view to reaching the goals of the Council of Europe."

Council of Europe reform: participation of civil society in danger

Written Declaration No 462

This written declaration commits only the members who have signed it

The undersigned members of the Parliamentary Assembly:

- honor the Council of Europe institutional structure, the "quadrilogue" guaranteeing the synergy between the highest levels of decision-making, citizens and the grassroots of the society;
- underline the role of the International Non-Governmental Organisations (INGO) Conference in this structure as a voice of people in Europe of all political outlooks and all social and cultural origins;
- are concerned about the Council of Europe planned financial reform, proposed within the framework of 2011 budget, foreseeing over a 50 % reduction in the INGOs Conference budget (which represented 0,52 % of the 2010 global budget);
- underline that such budgetary cuts would sacrifice the Conference of INGOs activities and means of subsistence;
- urge the Committee of Ministers to consider other means of rationalisation and saving and to review the draft budget for 2011 accordingly.
